

## Lifetime Structural Warranty

The Range are covered by a Lifetime Structural Warranty. Under normal residential conditions and with proper maintenance, the product will be free of structural defects such as delamination, buckling and twisting. This structural warranty does not cover surface wear which is covered below.

## 30 Year Residential Wear Warranty

The Range is covered by a 30 Year Residential Wear Warranty. Under normal residential conditions and with proper maintenance, the wear layer system will not wear through within 30 years from the date of installation. Gloss reduction and scratches are not considered wear through and are therefore not covered by this warranty. Please refer to our Residential maintenance guide for information on how to maintain your floor.

## 10 Year Commercial Wear Warranty

The Range is covered by a 10 Year Commercial Wear Warranty. Under normal commercial conditions and with proper maintenance, the wear layer system will not wear through within 10 years from the date of installation. Gloss reduction and scratches are not considered wear through and are therefore not covered by this warranty. Please refer to our Commercial maintenance guide for information on how to maintain your floor.

## These warranties are offered under the following conditions:

### 1. Installation

The product must be installed in strict accordance with the current written installation instructions.

Please refer to Terra Mater's Installation Instruction and Maintenance Guide.

### 2. Wet Areas

The product can be installed in bathrooms, saunas, laundries and any other area in which high levels of steam and or moisture are present however local, state and federal standards for water proofing may require additional procedures for compliance.

### 3. Indoor Use Only

The product is for indoor use only and is not to be installed outdoors.

### 4. Maintenance

The product should be regularly cleaned and maintained in strict accordance with our current written maintenance instructions. It is recommended that only the approved cleaning products set out in the maintenance guide should be used. Use of unauthorised cleaning products or agents such as oils, ammonia-based cleaning liquids, etc., will void all warranties.

### 5. Limited Warranty

The structural and wear warranties for the product set out above are limited to the original purchaser and may not be assigned or transferred. In the case where a builder makes the purchase, these warranties are limited to each of the builder and the owner of the residence who first purchases the residence (or the floor) directly from the builder within 1 year after practical completion of the floor's installation.

Your sole remedy under these warranties is (at the election of Terra Mater Floors) for the product to be repaired, replaced or reinstalled subject to and in accordance with this warranty document.

## Exclusions to Warranties – The following are excluded from these warranties:

### 1. Colour Variation

Effort has been expended to create a realistic analogue of natural timber flooring. This product has been designed to mimic the natural variation inherent in real timber flooring and therefore samples displayed and or provided are indicative only and will not necessarily match the floor installed. Other variations will also occur such as small knots, grain variation, gum/sap/insect marks and mineral marks. All variations are intentional and not considered defects therefore does not form a part of these warranties.

### 2. Subfloor Heating

Terra Mater Floors does extend its Structural Warranty and Wear Warranty to flooring installed on heated sub floors, however all instructions in the installation instructions document must be followed.

### 3. Subfloor flatness and structural integrity

The product requires a flat, unmoving subfloor.

Terra Mater **DOES NOT** extend its Structural Warranty or Wear Warranty to flooring installed on subfloors that exceed 3mm of deflection over a 3m straight edge. Doing so will void these warranties.

Subfloors that at the time of installation do not exceed 3mm of deflection over a 3m straight edge but subsequently deflect outside of 3mm will be excluded from these warranties.

Subfloors that shift, move or otherwise change their position or level will void these warranties.

### 4. Movement Noise

Movement noises are an inherent characteristic of this type of flooring. Movement noises are excluded from this warranty.

### 5. Extreme Conditions

#### 5.1 Temperature

The temperature in the home must be between 15-25 degrees Celsius throughout the year. Floors subject to temperature levels outside the recommended range can suffer swelling, cracking and gapping between boards. These warranties also exclude localised temperature damage such as damage caused by heaters, air conditioners or the like which causes the temperature of a section of floor to be outside 15-25 degrees Celsius.

#### 5.2 Ultraviolet Light Damage

Floors subject to regular sun exposure can discolour. Discolouration is not considered a product defect and is not covered by these warranties.

#### 5.3 Abuse or Misuse

These warranties do not cover abuse or misuse including but not limited to indentations, scratch damages caused by negligence or damage caused by high heel shoes, furniture or equipment, pet claws, pebbles or sand. Damage caused by spills (for example pet urine) is excluded from these warranties. Please refer to the maintenance guide for information on protecting your floor.

**Heavy objects such bookcases, billiard tables, kitchen units, that exceed 200kg/object area or if the load is greater than 30kg/cm<sup>2</sup> should not be placed on a floating system. Damage can occur due to incorrect expansion and lack of correct raft movement.**

#### 5.4 Water Damage

These warranties do not cover damage caused by flooding, leaking plumbing, overflowing hydrostatic pressure, moisture penetration through the subfloor or similar water damage.

#### 5.5 Alterations / Repairs

Any alterations or repairs to flooring that have not been authorised by us or are not undertaken by us or on our behalf, will void these warranties. This includes (without limitation) any unauthorised alterations or repairs carried out by you.

Repairs, reinstallation or replacement by us or on our behalf shall not extend the warranty period.

If Terra Mater Floors chooses to repair, reinstall or replace warranted planks:

- a) Terra Mater Floors is not obligated to provide for, or to incur the costs of replacing (or otherwise doing work such as resurfacing or refinishing in relation to) any flooring that is not defective under these warranties, but which surrounds flooring that is defective under these warranties. For example, if only part of a floor requires repair, reinstallation or replacement under these warranties, Terra Mater Floors' liability is limited to (at the election of Terra Mater Floors) repairing, reinstalling or replacing just the defective part of the floor, rather than the entire floor; and
- b) Terra Mater Floors is not liable for any sub flooring materials, adhesives, supplies or other items consumed in the course of repairing, reinstalling or removing the floor.

#### 5.6 Insect Infestation

These warranties do not cover any insect infestation once the product has left the factory. The product leaves the factory free of insect infestation.

## 6. Liability Limitations

The product is intended for use in residential settings with light to normal traffic conditions or commercial settings with normal traffic conditions. These warranties do not apply if the flooring is used outdoors or in a commercial environment where extreme traffic conditions make this product unsuitable for installation.

To the maximum extent permitted by law, the warranties expressly stated in this document are the only warranties provided by Terra Mater Floors for this product. All other warranties, representations, assurances, guarantees, duties (including negligence) and promises (whether expressed or implied and whether arising under general law or statute) by Terra Mater Floors are excluded to the maximum extent permitted by law.

These warranties only apply to 'First Quality' products. They do not apply to any products designated or sold as 'B Grade', 'factory seconds' or discontinued stock, which is sold "as is".

Except as stated herein, no other warranty, express or implied is provided, including any warranty of fitness for a particular purpose. No retailer, builder, specifier, installer, manufacturer, dealer, distributor, agent or employee has authority to increase the scope or alter the terms or coverage of these warranties. No agreement to replace or reinstall shall in any event act to extend the period of coverage of any warranty provided.

- a) under no circumstances shall Terra Mater Floors be liable or in any matter responsible for any claim, loss or damage arising from the purchase, use or inability to use its products or form of special, indirect, incidental, or consequential damages, including without limitation, lost profits, emotional, multiple, punitive or exemplary damages or attorney's fees, even if Terra Mater Floors or its representatives have been advised of the possibility of such damages before sale;
- b) in no event shall Terra Mater Floors be obliged to cover the costs of old or new replacement materials other than The product originally supplied, and any warranty thereto is limited to the warranty, if any, provided by Terra Mater Floors in relation to that replacement product at the time of replacement. Terra Mater Floors will endeavour to replace defective product with matching product. However, Terra Mater Floors reserves the right to use different products and products produced by other manufacturers if a matching replacement product is not readily available;
- c) in no event shall Terra Mater Floors' liability exceed the aggregate amount it actually received upon sale and installation of the defective materials at issue; and

- d) any claim under these warranties must be made within one month of the date upon which the defect first become known (or first should have been discovered) by the claimant and in any event by no later than expiry of the applicable warranty period. All claims under these warranties must be made in writing, and must include evidence of the purchase date and the identity of the original purchaser and installation date and location; without such proof, no warranty coverage will apply. All claims must be sent to Terra Mater Floors at the address stated below. All costs of claiming under these warranties are to be borne by the person making the claim. If Terra Mater Floors determines that your claim is not valid, Terra Mater Floors may charge you for any labour, materials and travel costs incurred by it in assessing the claim.

- a) Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure
- b) The benefits to you given by this warranty are in addition to your other rights and remedies under a law in relation to the goods or services to which this warranty relates
